

# Diocese of Leeds - Road Map out of Covid 19 Restrictions

#### Introduction

The Catholic Church has been one of the few organisations to continue to operate through the lockdown period enforced on the 4<sup>th</sup> January 2021. The government allowed the continuance of public worship with the hope that spiritual guidance would assist personal wellbeing and that this will continue during, what is hoped to be, the road to recovery.

The tables below will be guided by the government's guidance on easing restrictions across England. The government has communicated that decisions on easing restrictions will be led by data rather than dates. The indicative, 'no earlier than' dates in the tables are all contingent on the data available at each stage and could be subject to change.

#### Rate of Infection

Whilst current data indicates that the rate of infection has slowed dramatically, assisted considerably by the government's vaccination programme this does not give reason to think that it is now safe, as there is still a significant number of people contracting Covid daily. Some areas of Yorkshire still have high R rates compared to the rest of the country. There is still a long journey ahead for all our churches and church halls to be fully reopened without restrictions and updates will be provided at every stage.

#### **Reducing Risk of Infection**

The precautions below have been a main stay in reducing the risk of infection throughout the pandemic, until the government guidance tells us differently, the precautions will remain in place in our churches, church halls and any other relevant buildings.

## **Safe Behaviours**



## **Social Distancing**

All visitors to a place of worship are to follow the guidance on social distancing, people should be 2 metres apart or more than 1 metre apart where mitigation is in use or guidance allows otherwise.



# Hand Washing / Sanitising

Wash your hands with soap and water or use hand sanitiser regularly throughout the day.



### **Enhanced Cleaning of Surroundings**

Clean surfaces often. Pay particular attention to surfaces that are touched frequently, such as handles, light switches, work surfaces and electronic devices. Remember to allow sufficient time between services or permitted activities.



### Ventilation

Opening windows and doors at opposite sides or opposite ends of the building or room will assist in providing cross ventilation. Where this is not possible open windows and doors where possible, but be cautious not to compromise fire safety.



#### **Face Coverings**

A face covering must be worn in all public indoor settings, unless you are exempt, or the activity allows for it to be removed.

# **Reducing Risk**

Restrictions have been eased in line with the government's roadmap, we will hopefully also start to see our church halls being used more frequently, for some with multiple use. With this there is not only the Covid measures that we have to ensure are still in place and sufficient, but we must also ensure that our buildings are safe to allow people back into them after a long period of closure. Statutory measures that **MUST** be reviewed and implemented prior to opening our Parish Halls.

# **Other Users**

All other users of Parish Halls must provide suitable and sufficient risk assessments and insurance for the activities they are undertaking within them, this must also include the covid secure element until such a time that the government lift all covid measures that are in place.

#### **Local Authority Covid Officers/Inspectors**

Please be aware the local authorities have within their ranks Covid Officers that can randomly inspect your property's Covid measures. They do not need to make an appointment or give prior notice. Such visits have occurred to some churches within the Diocese. Please be aware that they have the power to produce you with an enforcement notice, fine or even close the premises, if they feel that measures are not sufficient.
